Stephen Tchudi is professor of English at the University of Nevada, Reno, where he teaches and writes in the composition and rhetoric program. He is co-director of "Reading and Writing in the West," a summer institute for teachers, and is coordinator of UNR's University Seminar program, which offers interdisciplinary experiences for first-year students. He previously taught at Michigan State University, where he received the Distinguished Faculty Award in 1990.

He is the author of some forty books for the general public, teachers, and young adult readers. Among his recent books are *The Interdisciplinary Teacher's Handbook* (with Stephen Lafer); *The New Literacy* (with Paul Morris); and *Change in the American West: Perspectives from the Humanities*. His young adult books include three novels, *The Valedictorian*, *The Burg-O-Rama Man*, and *The Green Machine and the Frog Crusade* (published in French as *La Croisade des Grenouilles*). His most recent nonfiction book for young adults is *Lock & Key: The Secrets of Locking Things Up, In, and Out*.

He is a past president of the National Council of Teachers of English and former editor of English Journal, and a past president of the Nevada State Council of Teachers of English and the current editor of their newsletter Silver

Sage.
